
On behalf of ANJO International, please find enclosed our application for reinstatement. As per my telephone conversation on 02-14-01 with your office, I was told I could submit a letter of explanation for our failing to submit our 2000 annual report.

ANJO International's parent company is based in Tokyo, Japan and having incorporated here in Florida in October 1998, is being solely operated by it's Vice President, a Mrs. Hitomi Willingham, whose understanding of the English language, as well as American business affairs are some what hindered. Due to this, Hitomi acquired the assistance of a CPA to "handle all business affairs", and was under the assumption this annual process was being done.

I to was brought aboard last month to help Hitomi with the interpretation of smaller business affairs, and while submitting a credit application on 02-12-01 for a new phone system, I indirectly discovered ANJO's "inactive corporation status".
