Please be advised that the undersigned represents the Company. It has been requested by Kathy Ashton of your department that we summarize the events leading to the Company's application for reinstatement with the Florida Department of State Division of Corporations (the "Division").

On or about April 29, 2005, the Company filed the 2005 Annual Report and paid the filing fee of \$150.00, as it had routinely done since the Company's incorporation in 1998. The Division on May 12, 2005 cashed said check. A copy of our check and report is attached for your reference. On April 25, 2006, while attempting to file the 2006 annual report, we discovered on the Division's website that the Company was not in good standing for not filing the 2005 annual report. In speaking with Ms. Eula Peterson of the Division we learned that the 2005 annual report was rejected since the named officer in the report had not signed it. My office then informed Mr. Peterson that Mr. Jose Manuel Belsol as President of a related entity signed the report in Mr. Mendez's absence. Ms. Peterson then instructed us to (i) seek a refund of the \$150.00 paid by completing a refund application (a copy of Ms. Peterson's communication of April 25, 2006 is attached for your reference) and (ii) proceed to file a reinstatement form together with a filing fee of \$300.00 to cover the fees for 2005 and 2006, which were both done on April 26, 2006 and on May 4, 2006. Copies of the 2006 Reinstatement Form and Application For Refund are also attached for your reference. On or about May 25, 2006 we received correspondence from the Division rejecting the reinstatement form since the reinstatement fee of \$600.00 was not paid. Based on the good faith showing above, we respectfully request that the Division (i) waive the reinstatement fee of \$600.0 (ii) proceed to file the Company's reinstatement form; and (iii) change the Company's status to active.
