ARTICLES OF INCORPORATION FOR FRED BURKHARDT PAINTING, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is FRED BURKHARDT PAINTING, INC.

ARTICLE II: DURATION:

This corporation shall exist perpetually, commencing on the date of the filing of these Articles, unless sooner dissolved according to law.

ARTICLE III: PURPOSE

This corporation is organized for the purpose of transacting any and all activities or business permitted under the laws of the United States and Florida.

ARTICLES IV: CAPITAL STOCK

This corporation is authorized to issue One Thousand (1000) shares of Common Stock at One (\$1.00) Dollar par value. The capital stock shall be paid in cash or in property, at just valuation to be fixed by the incorporator, or by the directors at a meeting called for such purpose, or at the organizational meeting.

ARTICLE V: INITIAL PRINCIPAL OFFICE

ARTICLE VI: INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII: BOARD OF DIRECTORS

Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this corporation who is also a director or an officer of such corporation, or who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorize any such contract or transaction with like force and effect as if he were not such director or officer of such other corporation, or not so interested.

ARTICLE XI:

The private property of the stockholders shall not be subject to the payment of the corporate debts to any extent whatever. The corporation shall have a first lien on the shares of its stockholders and upon any dividends due them for any indebtedness of such stockholders to the corporation.
