

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be GABRIEL BELLON, P.A.

The principle place of business of this corporation shall be at 555 N.E. 15TH STREET, SUITE 100, MIAMI, FL 33132.

ARTICLE II. NATURE OF BUSINESS






