Articles of Incorporation Of South East Mobile Automation Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I Name

The name of the corporation shall be South East Mobile Automation Corporation.

Article II Principal Office

Its principal office in the State of Florida is to be located at 882 Colonial Rd., in the County of Gadsden. The mailing address of this office shall be 882 Colonial Rd., Havana, FL. 32333.

Article III Shares

The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do, in any part of the world, viz.:

"The purpose of the corporation is to engage in the business of selling, repairing, restoring, and maintaining, both retail and wholesale, construction equipment and accessories, and contracting work incidental to or connected with such work."

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives stated above.
