The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation is SUPERIOR ELECTRONIC TECHNOLOGIES, INC.

ARTICLE II
PURPOSE

This corporation is organized for the purpose of the wholesale distribution of electronic components, and all other related activities as permitted under the laws of the State of Florida and the United States of America.

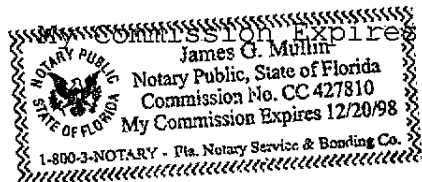
