#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME:

The name of this Public Service Corporation is: ABERCROMBIE & ABERCROMBIE, P. A., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
