ARTICLES OF INCORPORATION OF MICHAEL E. RAIM O.D.P.A.

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

NAME: The name of this corporation is MICHAEL E. RAIM O.D.P.A. and the principal place of business shall be at 619 Calhoun Avenue, Destin, Florida, 3254.

ARTICLE II.

DURATION: The corporation shall exist perpetually.

ARTICLE III.
