

#### ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator(s) pursuant to Chapter 607 of the Florida Statutes, adopt(s) the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of this Corporation is RP-Tech, Inc.

#### ARTICLE II. DURATION

The period of its duration is perpetual, beginning from the date these Articles are filed \_\_\_\_\_ with the State of Florida, Secretary of State.

#### ARTICLE III. PURPOSE

The general purpose of the business to be transacted by this Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida, and to effectuate such purposes it may act in any capacity including as an agent or attorney-infact for any person or entity.

#### ARTICLE IV. CAPITAL STOCK
