ARTICLE I NAME

The name of the Corporation is A MOTHER AND SONS, INC.. The address of the Corporation is 5617 Gibson Avenue, F-1, Tampa, Florida 33617.

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE
