**ARTICLES OF INCORPORATION**  
**THE HEALTH RIGHTS MOVEMENT, INC.**

ARTICLE I - NAME

The name of this Corporation is The Health Rights Movement, Inc.

ARTICLE 11 - DURATION

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This Corporation is formed for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue Five Thousand (5,000) Shares of Capital Stock with a par value of Ten (\$10. 00) Dollars each share, such shares to be designated as "Common Shares.


#### ARTICLE VIII - INDEMNIFICATION

IN WITNESS WHEREOF, the undersigned Incorporator has executed these Articles of Incorporation this 22<sup>nd</sup> day of September, 1998.




