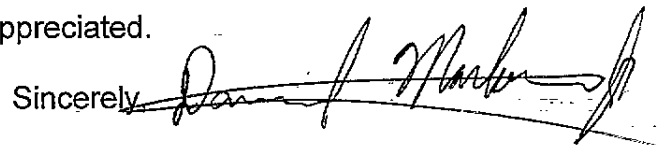

ARTICLES OF INCORPORATION
of
FAMOUS ENTERPRISES, INC.

This 13th day of October 1998, we, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

FIRST

The name of the corporation is: *Famous Enterprises, Inc.*

SECOND

The period of this corporation's duration shall be perpetual.

THIRD

The purpose of the corporation shall be to engage in any legal business activity that does not require special licensing by the State of Florida of the United States Federal Government.

FOURTH

The initial number of shares that the corporation is authorized to issue is five hundred (500) shares.

FIFTH

Each share of stock in this corporation shall have a par value of one dollar (\$1.00).

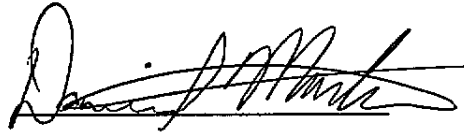
