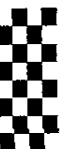

The private property of the Stockholders shall not be subject to payment of the corporate debts in any extent.

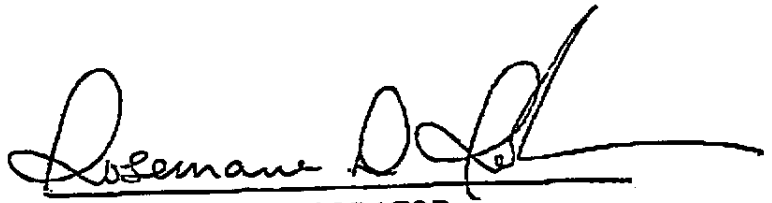

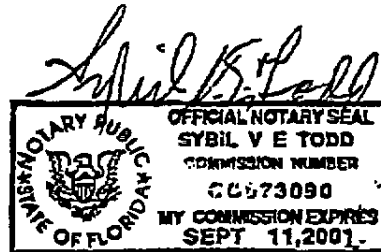
