To Whom It May Concern:

I placed a telephone call on 10/28/99 and spoke to a representative from your department regarding the reinstatement of my corporation "Raisin' Dough, Inc.". Unfortunately, I did not record the woman's name or her direct phone line extension.

The purpose of my phone call was to explain that for some unknown reason, I never filed the Annual Corporate Report for my company. This is my first year in business and I am still in the learning phase of all of the corporate tax and reporting requirements.
