

# **ARTICLES OF INCORPORATION**

## **ARTICLE I** **NAME**

The name of this corporation is EARLENE JORDAN WESTON & ASSOCIATES, INC.

## **ARTICLE II** **PURPOSE**

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

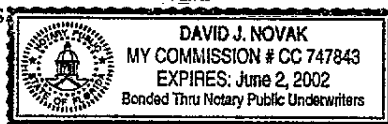
