The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be Dermatology, Enid F. Burnett, Inc., and it shall hereinafter be referred to as "Corporation".
