The name and address of the Incorporator of these Articles of Incorporation is: John Klaes, 2027 S. Ridgewood Ave., Edgewater, FL 32141.

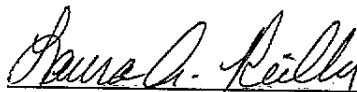
