### ARTICLES OF INCORPORATION OF LIGHTNING NETWORKS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I NAME

The name of the corporation shall be Lightning Networks, Inc.

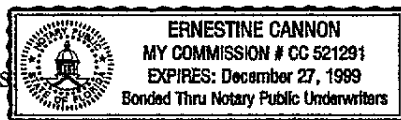
