ARTICLE 1

NAME

The name of this corporation is: MediTech Data, Inc.

ARTICLE 2

DURATION

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the articles of incorporation by the Department of State of the State of Florida.

ARTICLE 3

PURPOSE

This corporation is organized to engage in any one or more lawful businesses for which corporations may be formed under Florida law.

ARTICLE 4

SHARES

The aggregate number of shares which the corporation shall have authority to issue is 400,000, of which 200,000 shares will be common voting stock having a par value of \$0.01 per share and 200,000 shares will be common non-voting stock having a par value of \$0.01 per share.

The number of directors may be changed from time to time by the bylaws.






