ARTICLE I.

The corporate name that satisfies the requirements of Section 607.0401 is:

DAVID BROWN ENTERPRISES, INC.

ARTICLE II

The address of the principal office and the mailing address of the corporation is: 3130 Jasmine Drive, Delray Beach, Florida 33483.

ARTICLE III

The number of shares the corporation is authorized to issue is: One Thousand (1,000) shares of common stock at One Dollar (1.00) par value per share.

ARTICLE IV

To the fullest extent permitted by the Florida Corporation Law (as now in existence or hereafter amended), a director of the corporation shall not be liable to the corporation or its shareholders for monetary damages for breach of fiduciary duty as a director. Any repeal or modification of this Article shall not adversely affect any right or protection of a director of the corporation existing immediately prior to such repeal or modification.


