ARTICLES OF INCORPORATION

ARTICLE I
CORPORATE NAME

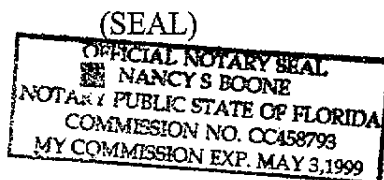
