SECOND: The filing date of the Articles of Incorporation was: October 15, 1998.

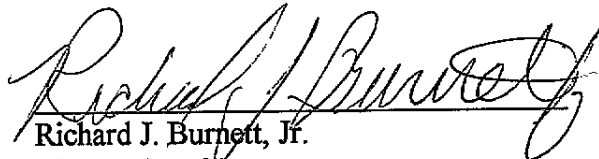
THIRD: None of the corporation's shares have been issued to the named shareholders in the Articles of Incorporation.

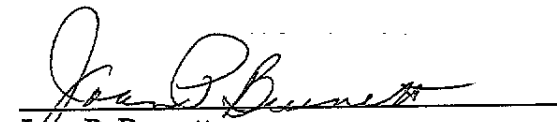
FOURTH: No debt of the corporation remains unpaid.

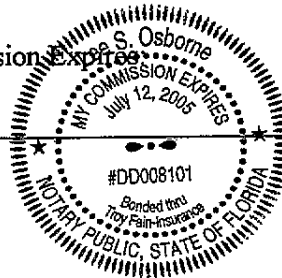
