ARTICLE XIII - CAPITAL AMOUNT


The amount of capital with which this corporation shall commence business shall not be less than Five Hundred Dollars ...00/100 - - (\$500.00).

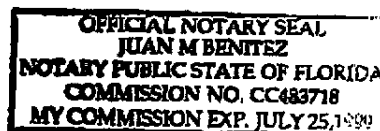
