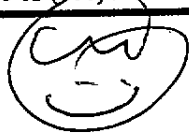

ARTICLE I - NAME

The name of this corporation is STP REDEVELOPMENT, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on October 15, 1998.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

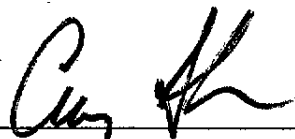

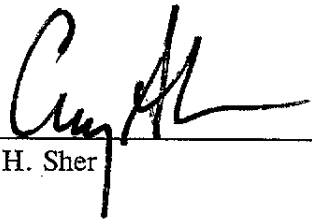
