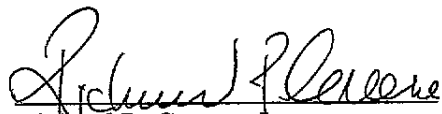
ARTICLE IX

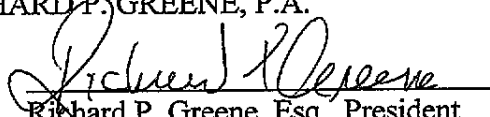
