ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
A BETTER HOME INSPECTION, INC.

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

01. The name of the corporation is A BETTER HOME INSPECTION, INC..
02. The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on September 29, 1999 in the manner prescribed by the Florida Business Corporation Act, following the unanimous adoption by the Board of Directors of a resolution setting forth the proposed amendment.

The name of the corporation is hereby changed to be PINE ORCHARD BUILDERS AND DEVELOPERS, INC. effective upon filing of the Articles of Amendment by the Department of State of the State of Florida.

03. One hundred percent of the shares of the corporation outstanding at the time of adoption were voted in favor of the amendment.
04. All of the directors and all of the shareholders of the corporation eligible to vote have signed a written statement manifesting their intention that the above amendment be adopted.

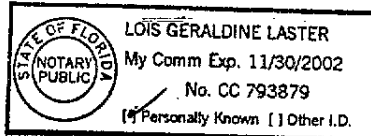

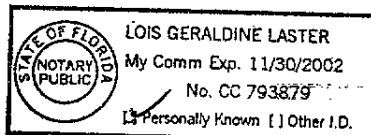
