ARTICLE I. The name of this corporation is Blast, Inc., operating at 18600 Sunrise Avenue, Miramar, Florida 33027

ARTICLE II. This corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III. This corporation is organized for the following purpose:
To engage in the transaction of any and all lawful business whatsoever.

ARTICLE IV. This corporation is authorized to issue One Million (1,000,000) shares of stock having a par value of \$.001 per share.

ARTICLE V. The street address of the initial registered office of this corporation is: 18600 Sunrise Avenue, Miramar, Florida 33027, and the name of the initial registered agent of this corporation is: Clifford R.
