## ARTICLES OF INCORPORATION OF ADVANTAGE RECEIVABLES MANAGEMENT, INC.

RYAN AYRES and DANIEL P. KELLEY, natural persons competent to contract do hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

#### ARTICLE I NAME
