**ARTICLE I**

**NAME**

This corporation may, at the option of the directors, file under Section 1244 of the Internal Revenue Code as a Subchapter S corporation.

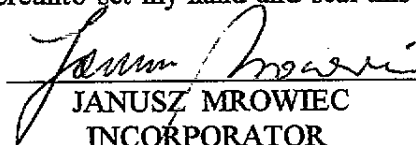
ARTICLE X

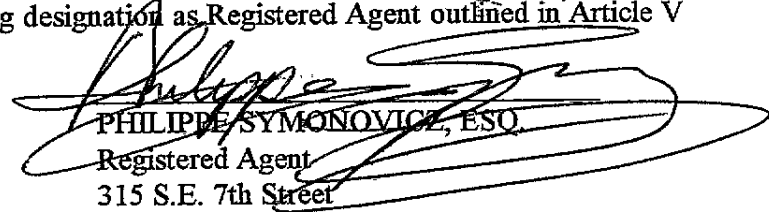
