The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopted the following Articles of Incorporation:

#### ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is: D & F GLOBAL ENTERPRISES, INC. The principal office and mailing address is 320 E. Adams Street, Jacksonville, FL 32202.

#### ARTICLE 2.0 DURATION

The duration of the Corporation is perpetual.
