The name of this corporation shall be New Age Consulting, Inc.

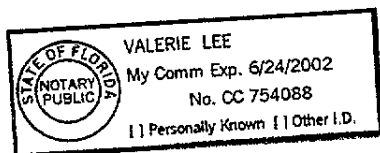



