**Articles of Incorporation
of
JONES TOWING, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I.
Name**

The name of the Corporation is JONES TOWING, INC., hereinafter referred to as the "Corporation."

**ARTICLE II.
Purposes**

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the United States, State of Florida, or any other state, country, territory or nation, as they may be amended from time to time.

**ARTICLE III.
Principal Office and Registered Agent**

The principal office of the Corporation is 4815/C West Colonial Drive, Orlando FL 32808. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida. The name and address of the registered agent for service of process upon the Corporation is Dennis Legassie, 4815/C West Colonial Drive, Orlando, FL 32808.

**ARTICLE IV.
Duration**

The duration of the Corporation shall be perpetual.

**ARTICLE V.
Initial Business**

The initial business of the Corporation shall be:
Vehicle Towing services of all kinds.
Wreckage towing services of all kinds.

ARTICLE VI.
Capital Stock

The Corporation is authorized to issue only one class of shares of stock which shall be designated Common Stock. The total number of shares the Corporation shall have authority to issue is 10,000, each share to have a par value of \$1.00.

The private property of the stockholders shall not be subject to the payment of corporate debts.

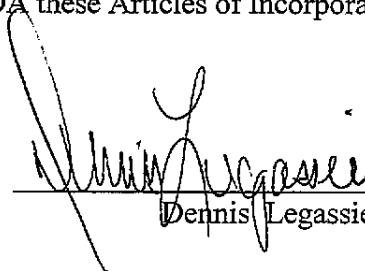
ARTICLE X.

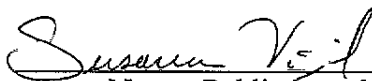
