1. The name of the corporation is:

#### F.A.B. CONSULTANTS, INC.

- 2. The purpose or purposes for which it is formed is as follows:
  - a) To conduct and carry on the business of implementation of accounting systems and development of accounting procedures for other businesses. To setup, train and advise businesses in all areas related to business in general, for the purpose of growth of the said businesses. To perform the function of an external accounting firm on a contractual basis. To provide consulting services in the area of tax planning, troubleshooting and all areas pertaining to both business and individuals tax needs. To provide support in all the above mentioned areas.
