ARTICLES OF INCORPORATION
OF
CURRY & COMPANY REAL ESTATE REFERRALS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I

The name of this corporation shall be CURRY & COMPANY REAL ESTATE REFERRALS, INC., hereinafter referred to as the "corporation".

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.


