# ARTICLES OF INCORPORATION FOR UENTERS CONSTRUCTION, INC.



The undersigned natural person hereby adopts the following articles of incorporation for the purpose of forming a business corporation under the laws of the State of Florida.

#### Article I. Name

The name of the corporation is VENTERS CONSTRUCTION, INC.

### Article II. Principal Office

The street address of the initial principal office and, if different, the mailing address of the corporation is:

223 Oak Street Port Orange, FL 32127.

## Article III. Capital Stock

The corporation is authorized to issue 1,000 (One Thousand) shares, all of one class, at no par value.

# Article IV. Initial Registered Office and Agent

# Article V. Incorporator

The corporation shall indemnify any present or former officer or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.

## Article X. Bylaw Amendment

The power to adopt, alter, amend or repeal bylaws of the corporation shall be vested in the board of directors and the shareholders provided that such amendment be in compliance with the laws of Florida governing corporations.

#### Article XI. Amendment

The corporation may amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this

reservation.
