Dear Mrs. Whitfield:

This is to remind you that the Uniform Business Report for this year must be filed in the office of the Secretary of State no later than May 1, 2001. The fee of \$150.00 must accompany the Report. A fee of \$550.00 is due, if the Report is filed after May 1st.

Failure to file such Report will result in an involuntary dissolution of the corporation by the Secretary of State. In such event, it may become necessary for you to change the name of the corporation before the Secretary of State will permit its reinstatement. The State charges for reinstatement, in addition to payment of all annual fees due. There are also other liabilities that may arise if the corporation is dissolved.

If you have not received such Report in the mail, we suggest you call our office for a substitute, which we can provide.

Before filing your Report, we suggest you first check the accuracy of the information contained therein. Florida law requires the Report contain the name and address of each officer and director, the name and address of the current registered agent, the current principal address of the corporation, and your Federal employer identification number for the corporation. It must be signed by any one of the following officers: President, Vice-President, Secretary, Assistant Secretary or the Treasurer.
