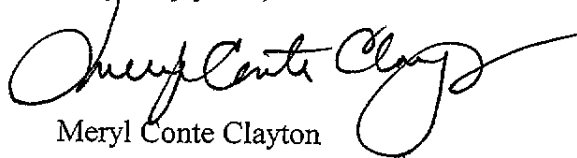

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE

The name of the corporation ("Corporation") is I.D.E.A. Manufacturing, Inc. 10-15-98

ARTICLE II

The existence of the Corporation shall begin on October 15, 1998.

ARTICLE III

The Corporation may engage in any lawful business.

ARTICLE IV

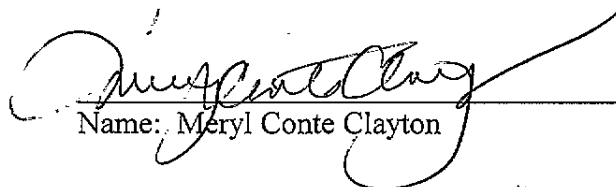
