**ARTICLE I. NAME**


ARTICLE VIII. INCORPORATOR

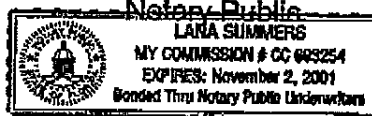
