Based on our discussion with the reinstatement section of the Department of State, the Corporation was dissolved in 1999 and needs to pay the fees for the year 2000, 2001, and 2002. The taxpayer has enclosed a check for \$458.75 in payment of the fees for these three years plus \$8.75 for a certificate of status.

Please be advised that the above referenced corporation never received the original annual reports for the years in question and accordingly, should not be subject to the late fee. This statement should be sufficient to allow you to waive this late fee.
