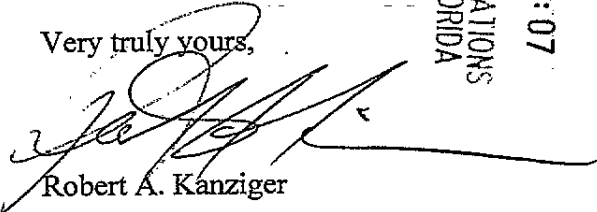

ARTICLE I. CORPORATION NAME.

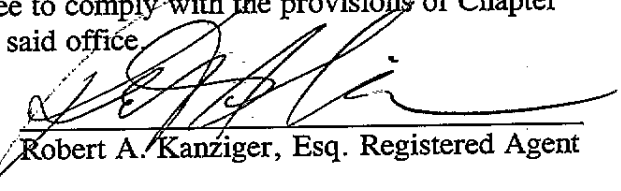
