ARTICLES OF INCORPORATION OF GLOBAL MARKETING CORPORATION OF DAYTONA, INC.

The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

GLOBAL MARKETING CORPORATION OF DAYTONA, INC.

and it shall be hereinafter referred to as the "corporation".

ARTICLE II

The time and date on which corporate existence of this corporation shall begin is 12:01 am (Eastern Standard Time) on October 9, 1998, and this corporation shall have continuous and perpetual existence thereafter.
