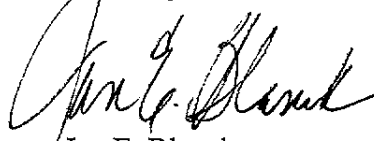

OF

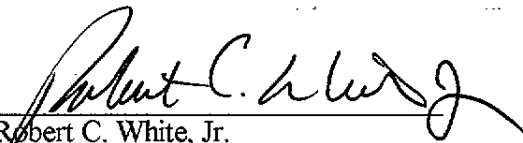

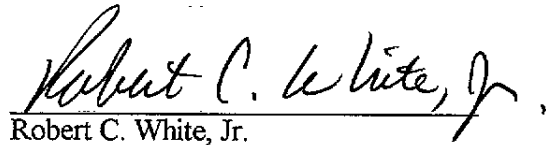
