**ARTICLES OF INCORPORATION
OF
COMMUNITY BROADCASTING CORPORATION**

In compliance with the requirements of Chapter 607, *Florida Statutes*, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is Community Broadcasting Corporation ("Corporation"). The initial street address of the principal office of the Corporation is 1501 Park Avenue East, Tallahassee, Florida, 32301 or at such other place within the State of Florida as the Board of Directors may designate.

ARTICLE II - NATURE OF BUSINESS

The Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States and the State of Florida, or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares this Corporation is authorized to issue is 3,000,000, all of which shall be common shares (Common Shares). All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE IV - INITIAL REGISTERED AGENT AND STREET ADDRESS

The name of the registered agent is Igler & Dougherty, P.A., 1501 Park Avenue East, Tallahassee, Florida 32301, which address is also the address of the Registered Office of the Corporation.

ARTICLE V - DIRECTORS

The initial Board of Directors shall consist of one (1) members. The name and address of the person who will serve on the initial Board of Directors is:

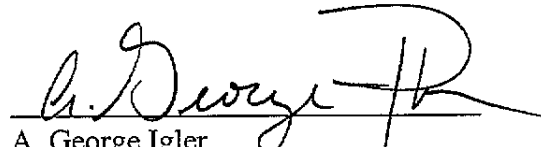
ARTICLE VII - INDEMNIFICATION
