The name of the corporation is Automotive Inc. Of P C .

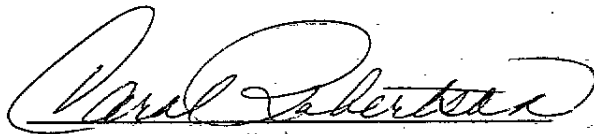
