ARTICLE ONE

NAME _____



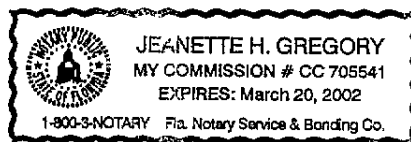
