
I recently received your notification that each of the above three corporations were administratively dissolved or revoked for failure to file the annual report/uniform business report.

I am enclosing herewith the subject annual reports, and respectfully request that you reinstate the corporations for payment of the original fees only. I believe the following mitigating circumstances will show reasonable cause for the late filings.

I purchased the three subject corporations from Phillip E. Johnson in April of this year. At the time, Mr. Johnson assured me that all corporate filings were up to date with the State of Florida. The first indication that I had that the annual reports had not been filed was when the above described notification was forwarded to my attention by the manager of the three Companies. The corporations are in their infancies and are still showing substantial operating losses; therefore the reinstatement fees would make the survival of the companies even more tenuous.
