
I recently received your notification that the above corporation was administratively dissolved or revoked for failure to file the annual report/uniform business report.


I am enclosing herewith the subject annual reports, and respectfully request that you reinstate the corporation for payment of the original fees only. I believe the following mitigating circumstances will show reasonable cause for the late filings.

I moved here from Colorado and took the position of manager of TIO of Tampa Bay, Inc., as of January 10, 2003. I did not have the benefit of meeting the previous manager because she left before I arrived, and was left no instructions of business matters that were left undone. The owner is an absentee owner and I am unfamiliar with Florida law as it relates to required registration of a domestic corporation. The first time I was aware that the annual report was required and had not been filed was when the above described notification was received in the mail this month. I had not received any prior notifications from your office. The corporation is now in its fourth year and is still showing substantial operating losses; therefore the reinstatement fees would make the survival of the companies even more tenuous.

Thank you for your kind consideration of this request for reinstatement.
