The name of this corporation shall be GP and S Trucking, Inc., and the address of the principal office of the corporation is 109 H E. Villa Capri Circle, DeLand, FL 32724.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

The name and address of the incorporator of this corporation is GERALDINE WOOD, 109-H E. Villa Capri Circle, DeLand, Florida 32724.


ARTICLE VIII - BY-LAWS

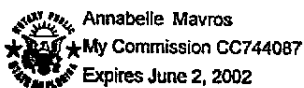


