TO
ARTICLES OF INCORPORATION
OF
AMERICA CARGO GSA, INC.**

SECURITY

I.

The name of the corporation is AMERICA CARGO GSA, INC. (the "Corporation").

II.

The Articles of Incorporation of the Corporation, as previously amended, are hereby amended to add the following new Articles IX and X thereto as follows:

"ARTICLE IX. PREEMPTIVE RIGHTS

The Corporation elects to have preemptive rights effective as of the date hereof, and the issuance of shares is subject to preemptive rights in favor of the shareholders of the Corporation as set forth in the Shareholders Agreement entered into between the shareholders of the Corporation on January 12, 2017, as amended from time to time.

"ARTICLE X. TRANSFER RESTRICTIONS

Until such time as the shares of common stock of the Corporation have been duly registered under the Securities Act of 1933, as amended, and under the securities laws or acts of other states, no shareholder of the Corporation shall sell, assign, transfer, mortgage, pledge, grant a security interest in, or otherwise encumber (including by operation of law), or contract to do or permit any of the foregoing, as to any or all of its securities other than non-convertible debt without the prior consent of the Board of Directors or shareholders of the Corporation by majority vote thereof by resolution thereof, or as otherwise provided in any unanimous shareholders agreement that may be applicable, which consent may be withheld in the sole discretion of the Board of Directors and/or shareholders of the Corporation."

III.

This Second Articles of Amendment to the Articles of Incorporation of the Corporation was duly adopted pursuant to Section 607.1003(6) of the Florida Business Corporation Act by the unanimous resolution of the holder of all of the issued and outstanding shares of common stock of the Corporation on January 12, 2017, and the number of votes cast was sufficient for approval.

Except as amended hereby, all of the other provisions of the Articles of Incorporation of the Corporation remain in full force and effect.

IN WITNESS WHEREOF, the Corporation has caused these Articles of Amendment to be executed on this 12th day of January, 2017.
