ARTICLES OF INCORPORATION OF MEDICAL SERVICES NET, INC.

ARTICLE I.

NAME

The name of this corporation is Medical Services Net, Inc.

ARTICLE II.

PRINCIPAL OFFICE

DURATION; EFFECTIVE DATE

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
